Parade Application Instructions

The Brookside St. Patrick's Parade will be held on Saturday, March 16, 2013, at 2:00 PM. The parade will begin at 65<sup>th</sup> and Wornall; heading north on Wornall; east on 63<sup>rd</sup>; south on Main; west on Meyer and ending at Brookside Blvd.

1. Please complete the application in its entirety. Deadline for entry is **March 10, 2013**. There is no charge to participate in the parade. Final selection of parade participants is at the sole discretion of the Brookside Business Association.
2. All applications must be signed by your organization's responsible person. This person is accountable for your group following the rules and regulations in order to help keep the parade safe for everyone.
3. There is a limit of 100 entries in the 2013 parade.

**Parade Rules and Regulations**

1. **Absolutely no alcohol** in the parade.
2. This is a fun, family event. All entries should reflect this. No offensive or lewd floats or signs will be allowed.
3. **No throwing of candy** or other items from cars or floats. People may walk along with your vehicle and hand out candy directly to those viewing the parade.
4. Please respect our Brookside neighbors and stay off private property during the line-up and during the parade.
5. No getting on or off of vehicles or floats while the parade is in progress.
6. No unsupervised youth.
7. No skateboards or roller blades.
8. Units with animals must clean up after the animals.
9. Please inform the Brookside Business Association of any diesel engines.

**Any violations of the above rules will result in ejection from the parade.**
